ORDER:

In the G.O. Ms.No.1 dated 21<sup>st</sup> February, 2013, orders were issued to implement tendering of works, goods and services costing Rs.10 lakhs and above through the Government e-Procurement portal of U.T of Puducherry viz. <https://pudutenders.gov.in>, as advised by the Govt. of India, Ministry of Commerce & Industry, Department of Commerce (Supply Division), New Delhi which is funding this Mission Mode Project under National e-Governance Plan. The said Ministry has recently reviewed the progress of implementation of e-Procurement in U.T of Puducherry and it has felt that the volume of tenders processed through the e-Procurement platform is comparatively low though the infrastructure for migrating to this new system is readily available. Hence, the said Ministry has recommended to scale up the volume of e-procurement by reducing the threshold value of e-tendering and by including more Departments in the ambit of e-Procurement. As advised by the said Ministry, the said G.O. dated 21<sup>st</sup> February, 2013, shall be amended as follows, namely:

**AMENDMENT**

In the said G.O. dated 21<sup>st</sup> February, 2013, for para 2, the following shall be substituted namely:

*" 2. It has now been decided that all the departments and their attached offices and Boards/Corporations/Societies/Autonomous/Statutory bodies of Government of Puducherry shall henceforth adopt Government e-procurement system in respect of procurement of goods, services and for executing works with an estimated value of Rs.5 lakhs or above with effect from the month of October, 2013. "*
